PROPOSITION #1 - PROPOSED BUDGET 2017-2018

ALSO, BE IT RESOLVED THAT UPON THE RECOMMENDATION OF THE SUPERINTENDENT OF SCHOOLS, THE BOARD OF EDUCATION OF THE AUBURN ENLARGED CITY SCHOOL DISTRICT, ACCEPTS THE **1882 "YES"** VOTES AND **828 "NO"** VOTES FOR THE BUDGET OF EXPENDITURES OF THE AUBURN ENLARGED CITY SCHOOL DISTRICT FOR THE 2017-2018 SCHOOL YEAR AND APPROVES AN AMOUNT NOT TO EXCEED \$75,272,249 OF THE AMOUNT THEREOF SHALL BE RAISED BY A LEVY OF TAX UPON THE TAXABLE PROPERTY OF THE SCHOOL DISTRICT, AFTER FIRST DEDUCTING THE MONIES AVAILABLE FROM STATE AID AND OTHER SOURCES AS PROVIDED BY LAW:
